Terms and Conditions

1. Entrants must be over the age of 18 or have permission from a parent or guardian to make a nomination.

4. Nominated players with former NRL experience must have been retired from the elite level for a period of no less than five years.
5. Nominated individuals and families must be emotionally and/or physically and/or financially necessitous.
6. The nominations officially open on Thursday 25 July 2019 at 9am AEST
7. The nominations officially close on 31 October 2019 at 5pm AEST.
8. Entries will only be accepted via the official nomination form.
9. Employees of the Parramatta Eels and the Men of League Foundation are not permitted to enter.
10. By entering this process, entrants consent to using their image for all promotional collateral to promote the Parramatta Eels and Men of League Foundation; this includes print, online and digital.
11. Any changes to the nomination process will be notified to entrants as soon as possible.
