Introduction

The Parramatta Eels are excited for the upcoming trials for our Development Squads and Junior Representative Teams! We greatly appreciate your continued involvement and dedication to Rugby League within the Parramatta District. Your passion and enthusiasm drive our community forward. The important information you need to know about the trial process is contained within this document including the important dates, which are listed on the last page.

Important Junior League Policy

In accordance with the Junior League Policy 2.12 to 2.22, players selected from the Parramatta District to represent other district teams during the season must obtain permission from the Parramatta National Rugby League to return and participate in the Parramatta Junior League at the end of the District Representative season.

This requirement ensures a smooth transition for players, allowing them to return to their original junior league clubs if desired. Without this permission, players may not be allowed to register with a Parramatta Junior League club for the following season, specifically for the 2027 season. ***For all players not selected to trial, they are free to trial in any other district and return at the completion of their commitments to their chosen Junior League Club.***

Decision Making and Commitment

Choosing not to trial for the Parramatta Eels Development and Representative Teams, or accepting a position with another district, is a significant commitment for young athletes. It is essential to consider the potential implications of this decision, as it may affect your ability to return to the Parramatta Junior League in the subsequent season if permission is not granted. **In short if you do not accept a position to trial or a position in the Eels squads, then your registration in the Parramatta Junior League in 2027 cannot be guaranteed.**

Nomination & Registration	Participation in these trials are by Club nomination only – they are for players born 2008 to 2012 <u>Monday, August 10th</u> – PJRL clubs will receive the nominations link TEAMS IN GOLD DIVISION = 10 nominations TEAMS IN SILVER DIVISION = 5 nominations ** Clubs with both Gold & Silver teams in the same age group can only nominate from the Gold division. <u>Monday, August 10th</u> – Any player who is exempt from the trial process will receive notification from the Parramatta Eels Pathways Female Recruitment manager before this date.
