

Peoplecare x NRLW Parramatta Eels Giveaway Terms and Conditions 2026

PEOPLECARE HEALTH INSURANCE

Competition details:

There is 1 prize to be won, containing 4 tickets.

Entering is easy – simply enter in your details via the Tradable Bits platform and you'll go in the draw to win. The winner will be selected via a **random electronic draw using the Tradable Bits platform** and directly contacted by the Parramatta Eels team to arrange ticket distribution.

1. Information on how to enter, prizes and other details contained within promotional advertisements for the Peoplecare x NRLW Parramatta Eels Giveaway (the **Promotion**) form part of these terms and conditions. Entry into the Promotion is deemed to be an acceptance of these terms and conditions. Entries must comply with these terms and conditions to be valid.
2. **Promoter:** The promoter is Peoplecare Health Limited, 2-12 Young Street, Wollongong, NSW 2500 (ABN 95 087648 753), telephone number (02) 4224 4333 (**Promoter**).
3. **Administrator:** The promotion is administered by the Parramatta Eels (ABN: 66 092 536 519), Parramatta Eels, Kellyville Memorial Park, Memorial Ave, Kellyville NSW 2155 ('Administrator'), responsible for conducting the draw, notifying the winner and distributing the prize on behalf of Promoter.
4. **Platform provider:** The promotion is hosted via the Tradable Bits platform. A third-party service provider who is not the promoter or administrator of the Promotion.
5. **Who can enter:** Entry into the competition is only open to persons over the age of 18 years. The following persons are ineligible to enter the Promotion:
 - Anyone under 18 years of age
 - Peoplecare Health Insurance employees
6. **Promotion Period:** This Promotion will be open from 6:00am AEDT Wednesday 1 July to 11:59PM AEDT on Monday 17 August 2026 (**Promotion Period**). No late entries will be eligible to enter the Promotion.
7. **How to enter:** To enter the Promotion, an entrant must, during the Promotion Period, submit an entry via the Tradable Bits platform by providing an eligible first name, surname and email

address. All eligible entrants who submit their details via the Tradable Bits platform will be automatically entered into the draw of the Promotion unless they request otherwise.

11. The Promoter may at its absolute discretion substitute a different prize of equal value in place of the prize referred to in these terms and conditions. No bonus prizes will be awarded.
12. **Notification:** The winner will be notified directly **by the Administrator** via email within 2 business days following the draw. The winner agrees to allow the Promoter to post their first name and last initial on the Promoter's website and/or the Promoter's social media.
13. **Claim prize:** The winner must respond to the Administrator by email within 5 business days following the draw to claim the prize.
14. **Unclaimed prize:** If the winner does not claim the prize within 5 business days following the draw, they will be deemed to have forfeited the prize. The winner of the prize at the redraw will be notified by email within 2 business days of the redraw.
15. **Winners:** Where requested by the Promoter or Administrator, the winner must provide evidence which, to the reasonable satisfaction of the Promoter or Administrator, demonstrates that he or she is the winner, is eligible to enter and has complied with these terms and conditions.

19. **Liability and release:** The Promoter shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for any personal injury, loss or damage suffered or sustained (even caused by negligence) in connection with accepting or using a prize or participating in this Promotion, except for any liability which cannot be excluded by law.
