

Inchcape Subaru Sydney PJRL Little Legends Raffle

Terms and Conditions

1 Promoter

The Inchcape Subaru Sydney PJRL Little Legends Raffle will be conducted for the benefit of Parramatta National Rugby League Club Pty Limited, 304 Stone Mason Dr, Kellyville, NSW, 2155 by the Promoter, Trivett Automotive Retail Pty Limited (ABN 61 065 072 498) trading as Inchcape Subaru Sydney, Level 3, 58 Norwest Boulevard, NORWEST, NSW, 2153 whose authority to fundraise can be verified with the beneficiary.

2 Permit Number

The raffle is conducted under NSW Art Union Authority GOCAU/2372.

3 Relevant State(s)

Entry is open to residents of New South Wales aged 18 years or older.

4 Promotion Period

The raffle will commence on 22/05/2026 and close at 5:00 PM on 24/08/2026.

7 Entry Restrictions

Entry is open to residents of the Relevant State(s) aged 18 years or older at the commencement of the Raffle. Tickets cannot be purchased by any individual involved in the organisation of the raffle or the draw. In addition, tickets cannot be purchased by Parramatta Eels board members or management, or by employees of Trivett Automotive Retail Pty Limited, or their respective immediate* family members. Entry is not permitted to anyone involved in the organisation of the raffle including family members. If family members are drawn their entries will be forfeited and their ticket purchases will be refunded.

** Immediate family means a person's spouse, siblings, and family members residing at the same premises as the person.*

8 Verification Requirements

The raffle will be drawn at 11.00 AM AEST on 25/08/2026 at Subaru Head Office at Level 3, 58 Norwest Boulevard, NORWEST NSW 2153. Six (6) entrants will be drawn and will be deemed the six (6) winners for the Minor Prize ('Minor Prize **Winners**'). The draw will take place in accordance with State Government regulations. The draw will be conducted by the Promoter. Draw method: An electronic draw will be conducted.

10 Prize Details

The Minor Prize is 6 double passes to the Inchcape Subaru Corporate box at CommBank Stadium to watch Eels vs Sharks on 30th August 2026. From this game, Minor Prize Winners will be taken onto the field at half time for a chance to win a Subaru Impreza ('**Major Prize**').
