

# Parramatta Eels x SIPENERGY Competition

## Terms & Conditions

### WHO CAN ENTER?

1. Information on how to enter and prizes form part of these Conditions of Entry.
2. Entry into this promotion is deemed acceptance of these Conditions of Entry.
3. Entrants must own their own home and be based in Sydney, NSW.
4. Employees (and their immediate families) of SipEnergy Pty Ltd (ABN 41 641 001 032), Parramatta Eels (ABN 70 355 352 183) and their respective agencies (“the Promoters”) are ineligible to enter or win.
5. The Promoters reserve the right to verify the validity of entries and to disqualify any entrant who:
  - Submits an entry not in accordance with these Conditions of Entry, OR
  - Interferes with the entry process, OR
  - Fails to meet eligibility criteria.

### HOW TO ENTER`

#### 1. Competition Period

Competition commences on 15th April, 2026 at 9:00 AM (AEST) and closes at 11:59 PM (AEST) on 8th May, 2026.

Entries received outside this period will be invalid.

#### 2. Entry Method

Complete and submit the online entry form available at the SIPENERGY website during the Competition Period.

Only one (1) entry per person permitted; multiple entries will be invalidated.

#### 3. Entry Restrictions

Incomplete, indecipherable, or fraudulent entries, or those received after the Competition Period, will be invalid.

Proof of identity, age, homeownership, and NSW residency may be required to claim a prize.

### PRIZE DETAILS

#### Prize Description

There will be THREE (3) prize categories awarded:

#### First Prize — Solar or Battery System (1 Winner)
