Medical / Liability Wavier Period – September 1st, 2023 to October 31st, 2024

In line with the 'Player Health Insurance Policy' of the Parramatta Eels National Rugby League Club Pty Limited (PNRL). PNRL will accept no responsibility for the costs of injuries, physically, mentally or financially (including physiotherapy) incurred whilst the player is participating in matches or training with the Parramatta Eels National Rugby League Club.

I understand that participating with PNRL under this Train, Trial & Play waiver is voluntary and hereby acknowledge the following:

1. There are significant and obvious risks associated with the recreational activities involved in Training, Trialing and Playing Rugby League of which I am aware;
2. That the obvious risks referred to in clause one (1) are risks that, in the circumstances, would be obvious to a reasonable person in my position;
3. That the Club wishes to draw my attention to the definition of obvious risk under the Civil Liability Act 2002 (NSW), as follows:
"obvious risk" to a person who suffers harm is a risk that, in the circumstances, would have been obvious to a reasonable person in the position of that person.
4. That I am a reasonable person of sound physical and mental health and that I am fully willing and able to participate in the recreational activities to which this waiver refers, including Trialing, Training and Playing Rugby League;
5. That during all such times whilst Training or participating in Trials and/or Games with the Club and in utilising the resources of the Club's premises, the Club's gymnasium and at any associated playing field or training ground, both my property and my person shall be my own responsibility and I will not hold the Club or its directors or employees or agents liable for any personal injury or loss of property whether or not caused by the negligence of the Club, its directors, employees or agents;
