LOCAL TRANSFER AND PERMIT POLICY

1. BACKGROUND

- 1.1 The Parramatta Junior Rugby League (PJRL) needs to ensure that talented Players remain at and are attracted to its affiliated Clubs and Competitions to foster, promote and propagate the game of Rugby League throughout and within the Parramatta National Rugby League (PNRL) District.
- 1.2 Players who are members of PJRL affiliated Clubs are provided with Development Squad and Representative Team Pathways through the PNRL.
- 1.3 Players that play in the PJRL are expected to trial for Parramatta Eels Development Squads and Representative Teams until such time as they are released by Parramatta Pathways.
- 1.4 Development Squads and Representative Team participants are given specialised coaching and learn training techniques to improve their skills and build their chances of progressing to higher grades of rugby league.
- 1.5 The PJRL has an expectation that the Players who are members of affiliated Clubs apply the PNRL values of Accountable, All-In, United & Respect.
- 1.6 A Policy is required to complement the NSWRL Player Transfer Policy – Community Rugby League with respect to:
 - a) Development Player Quotas in Teams
 - b) Representative Player Quotas in Teams
 - c) Players who played in the PJRL who trialled for the Parramatta Eels, were not selected and played for another Junior Representative Club
 - d) Players who played in the PJRL who trialled for the Parramatta Eels and were offered a position and declined and chose to trial for another Junior Representative Club and played for that Club
 - e) Players who played in the PJRL who chose to not trial for the Parramatta Eels and trialled and played for another Junior Representative Club
 - f) Players who previously played in the PJRL and played for another Junior Representative Club and wish to return to the PJRL
- 1.7 Additional clauses may be added to the Policy to further clarify the likelihood of certain Player transfers.
- 1.8 The Policy also covers Permits from one Club to another and the transfer of full Teams from Sunday Clubs to Saturday Clubs if their Club does not offer Teams in Saturday Competitions.



2. POLICY

The Local Transfer and Permit Policy relates to:

Male – any Player registering for an Under 17s or younger Team, however Representative Quotas apply up to Under 19s.

Female – any Player registering for an Under 17s or younger Team, with Representative Quotas applying up to Under 17s.

Development Player Quotas in Teams

- 2.1 Development Players must return to the Club they played for the previous year.
- 2.2 Notwithstanding Clause 2.1, Division 2, 3 and 4 Players may request a clearance to another Club to play Division 1 with the permission of the Parramatta National Rugby League Club.
- 2.3 Notwithstanding Clause 2.1, if the Club a Development Player played for in the previous season is not fielding a Team, they may request a clearance to another Club.
- 2.4 The NSWRL Player Transfer Policy – Community Rugby League will determine the number of Players that can transfer into a Team.
- 2.5 If a Team is permitted to transfer Players into its squad, it may transfer additional Development Players into their squad pursuant to the below table:

| Age | Maximum Development Squad Members | Maximum Representative Team Members | Maximum Total Combined Development Squad and Representative Players |
|--------------------|-----------------------------------|-------------------------------------|---|
| U13, U14, U15 | 6 | NA | 6 |
| U16, U17, U18, U19 | 6 | 5 | 6 combined |

Notwithstanding that the Development Player and Representative Player Quota and combined total may increase at the discretion of the PJRL in consultation with the Parramatta National Rugby League Club should there be less than five (5) PJRL Division 1 Teams in an individual age group.

Representative Quotas in Teams

- 2.6 Representative Players must return to the Club they played for the previous year.
- 2.7 Notwithstanding Clause 2.6, Division 2, 3 and 4 Players may request a clearance to another Club to play 1st Division with the permission of the Parramatta National Rugby League Club.
- 2.8 Notwithstanding Clause 2.6, if the Club a Representative Player played for in the previous season is not fielding a Team, they may request a clearance to another Club.



- 2.9 The NSWRL Player Transfer Policy – Community Rugby League will determine the number of Players that can transfer into a Team.
- 2.10 A Player who is playing up a year in Representative Football may transfer up a year at the same Club regardless of Representative Quotas.

For example: A Player played U15s for Guildford in 2025, they are selected in the Harold Matthews squad in 2026 and are going to register to play a year up. They may transfer to the Under 17s Guildford Team regardless of representative quotas.

- 2.11 If a Team is permitted to transfer Players into its squad, it may transfer additional Representative Players into their squad pursuant to the below table:

| Age | Maximum Development Squad Members | Maximum Representative Team Members | Maximum Total Combined Development Squad and Representative Players |
|--------------------|-----------------------------------|-------------------------------------|---|
| U13, U14, U15 | 6 | NA | 6 |
| U16, U17, U18, U19 | 6 | 5 | 6 combined |

Notwithstanding that the Development Player and Representative Player Quota and combined total may increase at the discretion of the PJRL in consultation with the Parramatta National Rugby League Club should there be less than five (5) PJRL Division 1 Teams in an individual age group.

Players who played in the PJRL who trialled for the Parramatta Eels, were not selected and played for another Junior Representative Club

- 2.12 Players who played in the PJRL who trialled for the Parramatta Eels and were not selected and then trialled for another Junior Representative Club and were selected and played for that Club are permitted to return to the PJRL and return to the Club that they played for in the previous season.

Players who played in the PJRL who trialled for the Parramatta Eels and were offered a position and declined and chose to trial for another Junior Representative Club and played for that Club

- 2.13 Players who played in the PJRL who trialled for the Parramatta Eels and were offered a position and declined and chose to trial for another Junior Representative Club and played for that Club are not permitted to play for a PJRL affiliated Club in the next season.

For example: a Player played U16s for a PJRL affiliated Club in 2025, they trialled for the Parramatta Eels and were offered a position, they also trialled for North Sydney and were selected and chose to play Harold Matthews for North Sydney, they are not permitted to play for a PJRL affiliated Club in 2026.



Players who played in the PJRL who chose to not trial for the Parramatta Eels and played for another Junior Representative Club

- 2.14 Players who played in the PJRL who were offered a position to trial and chose to not trial for the Parramatta Eels and trialled for another Junior Representative Club and were selected and played for that Club are not permitted to play for a PJRL affiliated Club in the next season.

For example: a Player played for a PJRL affiliated Club, they were selected to trial and choose not to trial for Parramatta and solely trialled for North Sydney and were selected for their 2026 Harold Matthews Squad, they are not permitted to play for a PJRL affiliated Club in 2026.

- 2.15 Notwithstanding Clause 2.14, Players that submit a Permission to Trial Elsewhere Form and receive written consent from the Parramatta National Rugby League Club to trial elsewhere are permitted to trial and play for other Junior Representative Clubs and return to the PJRL Club that they played for in the previous season.
- 2.16 Players who played in the PJRL and were not selected to trial for the Parramatta Eels and trialled for another Junior Representative Club and were selected and played for that Club are permitted to return to the PJRL Club that they played for in the previous season.
- 2.17 Notwithstanding Clauses 2.15 and 2.16, Players that are contracted to other National Rugby League Clubs are not permitted to play for a PJRL affiliated Club in the next season.

Players who are registered to a PJRL affiliated Club and sign for another NRL Club during the season or take part in another NRL Club's Development Program

- 2.18 Players who are registered to a PJRL affiliated Club and sign with another NRL Club during the season, meaning they are unable to be selected for Parramatta Eels Representative or Development Squads will be stood down from playing for the PJRL affiliated Club.
- a) It is a Clubs responsibility to advise the PJRL if a player from their Club signs with another NRL Club. If that player plays for their PJRL affiliated Club they will be deemed an ineligible player pursuant to the Fees, Fines and Penalties Policy.
- 2.19 Players who are registered to a PJRL affiliated Club and take part in another NRL Clubs Development Program during the PJRL season will be stood down from playing for the PJRL affiliated Club.
- a) It is a Clubs responsibility to advise the PJRL if a player from their Club takes part in another NRL Club's Development Program. If that player plays for their PJRL affiliated Club they will be deemed an ineligible player pursuant to the Fees, Fines and Penalties Policy.

Players who previously played in the PJRL and played for another Club and wish to return to the PJRL

- 2.20 Players who previously played for PJRL affiliated Club and in the previous season solely trialled and played for another Junior Representative Club who wish to return to the PJRL may do so if they:



- a) Are selected in a Parramatta Eels Development or Representative Squad
- b) Are not contracted to another Junior Representative Club and they did not play in the PJRL in the preceding 12 months (it is a Club's responsibility to prove that a Player they are registering is not contracted to another Junior Representative Club)

For example: an U16s Parramatta Eels Development Player played for a PJRL affiliated Club in 2024, they solely trialed for the 2025 North Sydney Harold Matthews Team and were selected, they were not permitted to play for a PJRL affiliated Club in 2025. They are no longer contracted to North Sydney or any other Junior Representative Club, therefore they may return to a PJRL affiliated Club in 2026 and may transfer to any eligible Team in line with this Policy.

Players who are playing for other Junior Representative Clubs

- 2.21 A Player who has never played in the PJRL and is currently contracted to another Junior Representative Club is not permitted to register for a PJRL affiliated Club

For example: a Player played Under 15 Division 1 for the Forestville Ferrets in 2025 and is contracted to Manly through their U16s Development Squad, they are not eligible to transfer to Hills Bulls to play in the Under 16 Division 1 competition.

- 2.22 A Player who has never played in the PJRL and is not contracted to another Junior Representative Club is permitted to register for a PJRL affiliated Club

For example: in 2025 they played for Dundas Shamrocks and in 2026 they play Harold Matthews for Balmain Tigers but are not contracted to the Balmain Tigers beyond the 2026 Harold Matthews season.

Right of Parramatta National Rugby League Club

- 2.23 Notwithstanding Clauses 2.1 to 2.22, the Parramatta National Rugby League Club reserves the right to decline the registration of any player to a PJRL affiliated Club for any reason that is not in the best interest of the Parramatta National Rugby League Club and/or the PJRL.

Players Returning to the PJRL (U13s to U16s)

- 2.24 A Player who previously played in the PJRL and was transferred to another Junior League may return to the PJRL pursuant to the NSWRL Player Transfer Policy – Community Rugby League.
- 2.25 Players who do not qualify under the Player transfer permissions (i.e. wanting to transfer to a Division 1 Grand Final Team) may apply to the NSWRL for a Transfer Review.

External Transfers

- 2.26 All external transfers into the PJRL and out of the PJRL are handled by the NSWRL pursuant to the Player Transfer Policy - Community Rugby League ([click here](#)).

Permits

- 2.27 Players may permit from one Club to another pursuant to the NSW Community Rugby League Policies & Procedures Manual – Clause 1.2 Application to Combine Teams ([click here](#)).



Internal Transfers – Mixed U6 to U7

2.28 Players can transfer internally in the U6 to U7 age groups based on the following table:

| 14 POINT CAP PER AGE GROUP | |
|-----------------------------------|--------------------------|
| 7 POINTS | RED |
| 5 POINTS | YELLOW |
| 3 POINTS | BLUE/SUNDAY CLUBS |
| 1 POINT | GREEN |

For example:

A Player played for a PJRL Club in the Red Division in U6s the previous season, they are seeking to transfer to another PJRL Club the next year. If the Club they are transferring to accepts their transfer it will equate to 7 of that Clubs' 14 allowable points for the U7s Age Group.

2.29 Clubs shall have the authority to determine which players they wish to transfer into their roster. Effective 1 February, clubs are required to notify the PJRL of their selected players for transfer.

For example:

A Club receives 10 internal transfer applications in the Under 7 age group. From 1 February the Club must approve the Players they wish to transfer in based on the 14 point limit.

The Club decides to predominantly build from within and approves the transfers of one (1) Player from a Yellow Team (5 points) and three (3) Players from Blue Teams (9 points), totalling 14 and they advise the PJRL of those players.

2.30 Exceptional Circumstances may be considered ([click here](#))

2.31 Players must be fully cleared in the MySideline database prior to being active with their new Club. Internal Transfers will be considered from 1 February each year.

Internal Transfers – Mixed U8 to U11

For players aged 8, 9, 10 and 11 that are playing in their natural age group:

2.32 Players can transfer internally in the U8 to U11 age groups based on the following table:

| 21 POINT CAP PER AGE GROUP | |
|-----------------------------------|--------------------------|
| 7 POINTS | RED |
| 5 POINTS | YELLOW |
| 3 POINTS | BLUE/SUNDAY CLUBS |
| 1 POINT | GREEN |



For example:

A Player played for a PJRL Club in the Red Division in U9s the previous season, they are seeking to transfer to another PJRL Club the next year. If the Club they are transferring to accepts their transfer it will equate to 7 of that Clubs' 21 allowable points for the U10s Age Group.

- 2.33 Clubs shall have the authority to determine which players they wish to transfer into their roster. Effective 1 February, clubs are required to notify the PJRL of their selected players for transfer.

For example:

A Club receives 10 internal transfer applications in the Under 10s age group. From 1 February the Club must approve the Players they wish to transfer in based on the 21 point limit.

The Club decides to predominantly build from within and approves the transfers of one (1) Player from a Red Team (7 points), one (1) player from a Yellow Team (5 points) and three (3) Players from Blue Teams (9 points), totalling 21 and they advise the PJRL of those players.

- 2.34 Exceptional Circumstances may be considered ([click here](#))
- 2.35 Players must be fully cleared in the MySideline database prior to being active with their new Club. Internal Transfers will be considered from 1 February each year.

Internal Transfers – Male U12 to U17

- 2.36 Players can transfer internally in the U12 to U17 age groups based on the following tables:

| U12s to U17s DIVISION 1 | | |
|--------------------------------|--------------------------------|--------------------------------|
| 1st | 0 POINTS | 15 POINTS FOR AGE GROUP |
| 2nd | 0 POINTS | 15 POINTS FOR AGE GROUP |
| 3rd^ | 1 X DIV 1 | 15 POINTS FOR AGE GROUP |
| 4th^ | 1 X DIV 1 | 15 POINTS FOR AGE GROUP |
| 5th TO LAST | 21 POINTS FOR AGE GROUP | |

^ If a Club recruits an External Division 1 Player, that will count as their Division 1 Player – though they will maintain their 15 points for the Age Group

For U12s, team rankings are determined by their position on the U11 Division 1 Competition Ladder, as maintained in the backend of MySideline.

Team Rankings for U13s to U17s are determined by their finishing position in the Division 1 Finals Series:

Premier 1st, Runner Up 2nd, Lost in Final 3rd, Lost in Semi Final 4th, Lost in Qualifying Final 5th

U12s to U17s DIVISION 2 & LOWER

21 POINTS FOR AGE GROUP

NOTE: If four (4) Players leave a Team that finished 1st or 2nd in Division 1 (Red) then that Team will be allowed to transfer one (1) x Division 1 (Red) Player, though the points for the Age Group still apply (i.e. if they recruit 1 x Division 1 Player it will tally as 7 of their 15 points for the Age Group).

| PLAYER POINTS | |

| 7 POINTS | DIVISION 1 (Red) |

^ refer to Clauses 2.1 to 2.11

Examples:

Teams that finished 1st and 2nd in Division 1 (Red) Competitions can only recruit Players internally into their Team for the next season. The Club can transfer Players into their lower Division Teams pursuant to the Tables.

Teams that finished 3rd and 4th in Division 1 (Red) Competitions can recruit a maximum of one (1) Division 1 Player into their Team for the next season. If the Club chooses to recruit the Division 1 Player it will tally as 7 points of the 15 points available for the Age Group, hence they will have 8 further points across the Age Group.

2.37 Development and Representative Quotas apply pursuant to Clauses 2.5 and 2.11.

2.38 Clubs shall have the authority to determine which players they wish to transfer into their roster. Effective 1 February, clubs are required to notify the PJRL of their selected players for transfer.

Example 1:

A Club had a Team that finished 3rd in Under 13 Division 1 the previous season and receives 10 internal transfer applications in the Under 14 age group. From 1 February the Club must approve the Players they are going to transfer in based on the 15 point limit, and Development Squad Quotas.

The Club decides they need a balance of Players across the Age Group and approve the transfers of three Division 2 Players (15 points).

From 1 February, the Club is to accept the transfers of those three (3) Players and decline the other transfer applications for the Age Group. The PJRL will process the three (3) approved applications once advised by the Club.



Example 2:

A Club had a Team that won the Under 14 Division 2 Competition, they have decided they would like to promote to Division 1 in Under 15s. They advertise they will have an Under 15 Division 1 Team and have attracted interest through multiple transfer applications.

They decide to boost their Team and recruit three (3) Division 1 Players (21 points).

From 1 February, the Club is to accept the transfers of those three (3) Players and decline all other applications for the Age Group. The PJRL will process the three (3) approved applications once advised by the Club.

2.39 Clauses 2.1 to 2.11 and 2.48 apply

2.40 Exceptional Circumstances may be considered ([click here](#))

2.41 Players must be fully cleared in the MySideline database prior to being active with their new Club. Internal Transfers will be considered from 1 February each year.

Internal Transfers – Female Tackle Teams U12 to U17

2.42 The maximum number of Players that can transfer from one PJRL Club to another PJRL Club is two (2) per Team

2.43 A Club may decline the transfer of Players from their Club following four (4) transfers from the same Team

2.44 The maximum number of Players that can transfer from all PJRL Clubs to another PJRL Club is four (4) in total

2.45 Clauses 2.1 to 2.11 apply

2.46 Exceptional Circumstances may be considered ([click here](#)).

2.47 Players must be fully cleared in the MySideline database prior to being active with their new Club. Internal Transfers will be considered from 1 February each year.

Internal Transfers – Female League Tag Teams U10 to U18

2.48 The maximum number of Players that can transfer from one PJRL Club to another PJRL Club is two (2) per Age Group

2.49 A Club may decline the transfer of Players from their Club following four (4) transfers from the same Age Group

2.50 The maximum number of Players that can transfer from all PJRL Clubs to another PJRL Club is four (4) in total



- 2.51 Exceptional Circumstances may be considered ([click here](#)).
- 2.52 Players must be fully cleared in the MySideline database prior to being active with their new Club. Internal Transfers will be considered from 1 February each year.

Division 1 Grand Final Teams Transfer Permissions

- 2.53 The PJRL or the NSWRL may refuse to grant Registration Permission in competitive football age groups (12+), where the Player has been registered in a Division 1 team or a team in a higher age group within any NSWRL Competition (this includes competitions with only one Division) at any time within the previous 18 months, and where the Club which the Player intends Registering to play for a Team that qualified for the Division 1 Grand Final in that players current or correct age group in the previous season.

For example: Wentworthville & Cabramatta played in the Under 14 Division 1 Grand Final, a player played Under 14 Division 1 for Liverpool Catholic Club in the previous season, they will not be eligible to transfer to Wentworthville or Cabramatta in the Under 15 Division 1 competition.

Aged Out Players & Non-Affiliated Club Transfers

- 2.54 If a number of Players who have aged out of a Club that played on Sunday in the previous season are wanting to switch to Saturday in the upcoming season and their previous Club does not offer Saturday as an option, there is no limit on how many Players can transfer from the Sunday Club to a Saturday Club.

For example:

The Baulkham Hills Brumbies fielded a Sunday U12s Team in 2025 and they do not offer a Saturday Under 13s option in 2026, there is no limit on how many Players from Baulkham Hills Brumbies can transfer to the same Club.

- 2.55 A Female Player who has aged out of a Club that does not offer a female program may transfer to another Club that does. Their Internal Transfer will not count towards the new Clubs Transfer quota.
- 2.56 If a Club is not affiliated from one season to another, then the Players from the non-affiliated Club are free to transfer to a PJRL affiliated Club. Such transfers will not affect a Clubs' allowable quota of transfers pursuant to the NSWRL Player Transfer Policy – Community Rugby League and this Policy.

Playing in a Higher Age Group

- 2.57 Due to the changes to the rules of the game and the mandated implementation of the Player Development Framework, Players aged 5 to 12 must play in their natural age group.
- 2.58 If a Club does not have a Team in a Players' natural age group, then their Club/Parent must have a completed a Playing in a Higher Age Group Consent Form for approval ([click here](#)). This Form must then be sent to the PJRL by the Club prior to training and playing and must be authorised and uploaded to the Player's member record on MySideline.



Sunday Team/Team Permits (U10 to U12)

- 2.59 The NSWRL have allowed players aged 10 years old, 11 years old and 12 years old to play on both Saturday and Sunday.
- 2.60 Such players must register for the Club they are playing for on Saturday and either:
- a) Play in a Sunday Competition with their Saturday Club, or;
 - b) Permit to another Club that is fielding a Sunday Team
- 2.61 Sunday Teams are limited to a maximum of five (5) Division 1/Red Players from a Saturday Team.

For example:

The Baulkham Hills Brumbies are going to enter an Under 10s Team in a Sunday Competition. There are six (6) Players who play for the Kellyville Bushrangers in the Yellow/Blue Competition on Saturday that also want to play on Sunday - they all permit to the Baulkham Hills Brumbies to play in their Sunday Team.

The Guildford Owls have three (3) Saturday Teams in the Under 10 Age Group. They are going to enter a combined Team in the Sunday Competition with Players from each of the Saturday Teams. They are limited to five (5) players from their Division 1/Red Team(s). If they require further players to fill the Sunday Team, they may permit players from the Merrylands Rams Under 10s who play in the Yellow/Blue Competition.
